### **Terms of Reference**

Repair and reconfiguration of the Electrical System of the Chancery

The Approved Budget for Contract (ABC) is USD5,000.00 or its equivalent in IDR.

#### **General Conditions**

- 1. The quotation must include documents showing that the service provider is technically, legally, and financially capable to fulfil contract.
- 2. The quotation must be in IDR and for all the of items listed herein.
- 3. The quoted price shall be the final price and include all applicable taxes.
- 4. The prices quoted must be valid and not be subject to any changes.
- 5. The quotation must include a detailed price computation.
- 6. Prospective contractors shall conduct survey a survey of the electrical system of the Chancery

## **Contractor's Obligation**

- 1. The contractor must create a detailed report of wattage consumption of major electrical appliances.
- 2. The contractor must identify the recommended electrical load allowance for the Chancery.
- 3. The contractor must regroup and rebalance electrical power allocation for each area of the chancery. The contractor must ensure proper distribution of power allocation
- 4. The contractor must inspect of Miniature Circuit Breakers (MCB) and replace of weak MCBs.
- 5. The contractor must prepare three (3) original sets of Electrical Single Line Diagram of the Chancery's new electrical network.
- 6. The contractor must ensure that the new configuration of the electrical network is in conformity with the requirements of Perusahaan Listrik Negara (PLN), the electric power distributor, for the current and the recommended electrical load allowance for the chancery.
- 7. The contractor must submit the Single Line Diagram to the *National Committee for the Safety of Electrical Installations KONSUIL* and secure a Certificate of Operation Eligibility (SLO).
- 8. The contract must provide at least a one (1) year warranty for the part replacement and at least five (5) years warranty for the new electrical system.
