# INSTRUCTIONS TO BIDDERS AND TERMS AND CONDITIONS OF SALE

# 1. Introduction

- a. The Philippine Embassy in Jakarta, Indonesia (hereinafter, the SELLER), will receive bids for the public auction of one (1) lot of unserviceable properties as described in the attached list on an "As-Is-Where-Is" basis.
- b. This Section provides instructions to the bidders for the Public Bidding. The Seller may issue special instructions to bidders and may require additional documents from the bidders.

# 2. Cost of Bid

- a. The Bidder shall bear all costs in the preparation and delivery of their bids and the Seller shall in no case be responsible or liable for such costs, regardless of the outcome of the bidding process.
- 3. Time and Place for Inspection and Receipt of Bids
  - Inspection of the motorcycle may be done on 13 to 20 March 2023 between 10:00 a.m. and 3:00 p.m. at the Philippine Embassy, Jl. Imam Bonjol 8 Menteng Jakarta Pusat Indonesia.
  - b. Bids will be received on or before 20 March 2023, 5:00 p.m. at the Philippine Embassy, Jl. Imam Bonjol 8 Menteng Jakarta Pusat Indonesia. Bids submitted after the designated time and date will not be accepted.

#### 4. Eligible Bidder

- a. The following local or foreign persons shall be eligible to participate in this bidding:
  - i. Natural (individual) persons; and
  - ii. Sole proprietorships, partnership, and corporations duly organized under the laws of Indonesia.

#### 5. Subject of Bid

a. Bids shall be for the disposal of one (1) unserviceable motorcycle vehicle of the Philippine Embassy in Jakarta on an "As-Is-Where-Is" basis described as follows:

# 6. Bid Information

a. No Philippine government official and employee shall directly or indirectly give, nor shall any prospective or intending bidders be entitled to, any information regarding the bidding or on the prospective bidders, other than what is contained in the Bidding Documents.

#### 7. Preparation of Bid

- a. Bidders shall submit (1) bid envelope containing the required documents for the bid; and
- b. The envelope shall contain the following documents:
  - i. Copy of Passport Data page or National ID of the Bidder;
  - ii. Business Registration Certificate, if applicable;

- iii. Duly signed Instruction to Bidders and Terms and Conditions of Sale: and
- iv. Accomplished Offer to Bid Form.

#### 8. Bid Currency

a. In all bids, prices shall be express in written words and figures in Indonesian Rupiah (IDR). In case the discrepancies between prices in words and figures, the prices in words shall be considered as the bid price.

#### 9. Defective Bids

- a. At the time of opening of bids, a bid shall be considered defective in any of the following cases:
- b. Not properly filled-out form (e.g. unsigned bids); and
- c. Lacking in any of the documents required in clause 7.

#### 10. Failure of Bidding

- a. The Seller shall declare the bidding a failure in any of the following cases:
  - i. There is no bidding participant; il)
  - ii. All bidders fail to comply with the Terms and Conditions of Sale as prescribed in the Instruction to Bidders; and
  - iii. Complying bidders failed to meet the minimum bid price.

# 11. Award of Contract

- a. Award shall be made to the highest complying bidder;
- b. No transfer and/or assignment of Award or Contract shall be allowed:
- c. The Award shall be cancelled, and rendered ineffective if the winning bidder fails to secure, sign or acknowledge the Notice of Award or Contract, within seven (7) calendar days after receipt of written advice; and
- d. If the Award is cancelled or rendered ineffective, the Award will be given to the 2nd highest complying bidder.

#### 12. Payment

- a. The full amount covering the awarded item shall be paid in full by the winning bidder in the form of cash payable to the Philippine Embassy in Jakarta, within seven (7) calendar days upon receipt of the Notice of Award.
- b. No other form of payment shall be accepted; and
- c. In case of failure of full payment within the prescribed period, the award will be cancelled.

#### 13. Release/Haulage of Awarded Lot

 After payment, the awardee shall pick-up and transport the unserviceable properties within seven (7) calendar day, during regular office hours (8.00 um. - 5:00 p.m.), Monday to Friday.

- 14. Taxes, Customs Duties, Cost or Charges, Insurance
  - a. The winning bidder shall pay, in addition to the purchase price, any and all taxes custom duties, costs or charges of any kind or nature whatsoever levied or to be levied in connection with the sale of the unserviceable properties by competent authorities of the Government Indonesia; and
  - b. All expenses incidental to the pick-up and transportation of the unserviceable properties shall be borne by the winning bidder.
- 15. Acceptance of Bid and Waiver of Rights to Enjoin Protest
  - a. The bidder after having submitted the Bidding Documents, has deemed accepted the terms and specifications established by the Seller and therefore waive any rights it may have to seek and obtain a writ of injunction or prohibition or restraining order against the Seller, to prevent or restraining the bidding process or any proceedings related thereto, the negotiation or award of the contract to the winning bidder and the implementation of the awarded contract.
